Subscription & Payments

1.1

Upfront Payment

All subscription fees for **Lite**, **Pro**, and **Elite** tiers are due in full prior to service activation. Access to the Platform is granted only upon confirmed receipt of payment.

1.2

Late Fees

For recurring partnerships, any payment delayed beyond **30 days** shall incur a Late Fee of **5% per month** on the outstanding balance, compounded monthly until the balance is settled in full.

Hardware & Camera Equipment

RiseUp is a software-as-a-service provider. No hardware is required for standard Platform use. If the Customer requests a camera purchase, RiseUp will provide a third-party quote. Upon payment:

- The Customer gains **Full Ownership** of the hardware.
- The Customer assumes **100% Liability** for the maintenance, insurance, and safe operation of the equipment.
- RiseUp bears no responsibility for hardware malfunction, loss, or damage after delivery to the Customer.

Data Ownership & Export

3.1

Ownership

The Customer owns the **raw footage** they upload. RiseUp owns the **Metadata** (extracted positional X/Y data and AI-generated insights) and maintains a perpetual, royalty-free license to use anonymized metadata for improving its scouting intelligence engine and league coefficient models.

Limitation of Liability (The 12-Month Cap)

To the maximum extent permitted by Moroccan law, RiseUp's total cumulative liability for any claim arising from the use of the Platform — including tactical errors, data loss, or scouting inaccuracies — is strictly limited to the **total fees paid by the Customer in the 12 months preceding the claim**.

LEGAL NOTE

This limitation applies regardless of the form of action, whether in contract, tort (including negligence), or otherwise, and whether or not RiseUp has been advised of the possibility of such damages.

Governing Law & Dispute Resolution

This Agreement is governed by the laws of the Kingdom of Morocco. Any disputes shall first be subject to good-faith negotiation. If unresolved within 30 days, disputes shall be submitted to the competent courts of Casablanca Finance City (CFC), Morocco.

Modifications & Termination

RiseUp reserves the right to modify these Terms with **30 days' written notice**. Continued use of the Platform after the notice period constitutes acceptance of the revised Terms.

Either party may terminate this Agreement with **30 days' written notice**. Upon termination, the Customer's access is revoked and any outstanding fees become immediately due.
